Rules and Regulations

1. REGISTRATION & DEADLINES

Early Bird pricing ends Monday, September 1, 2026. After that the cost will go up by \$25

2. VENDOR RESPONSIBILITIES & STANDARDS

Booth Space: You will be provided with a 10x10 ft. space. You must provide your own tent, tables, and chairs.

Professionalism: Vendors must maintain a professional appearance. Booths must be attended by an adult at all times during festival hours.

Setup/Breakdown: Setup begins at 7:30 AM. All vendors must be ready for our committee walkthrough by 9:45 AM. To maintain the festival experience, breakdown is not permitted before 5:00 PM.

Cleanliness: Vendors are responsible for daily maintenance of their area. Please dispose of all trash in the provided on-site dumpster.

3. MERCHANDISE & CONDUCT POLICY

Faith-Based Environment: As a church-hosted harvest celebration, we require all merchandise to be family-friendly. We do not permit items depicting devils, ghouls, ghosts, witches, skeletons, or "scary" Halloween themes.

Right of Refusal: The Committee reserves the right to request the removal of any item deemed objectionable. Failure to comply will result in removal from the event without a refund.

Exclusivity: To support IRC fundraising, vendors are prohibited from selling bottled water or sodas.

Prohibited Items: No alcohol or pets are allowed on church property.

4. PARKING & LOGISTICS

After unloading, all vehicles must be moved to the designated off-site vendor parking lot by 9:30 AM.

A shuttle cart will be available throughout the day to assist you with resupplying your booth if needed.

5. APPLICATION REQUIREMENTS

To ensure a variety of unique vendors, please submit:

- A completed application and signed agreement.
- Payment in full (Check or Credit Card).
- Three (3) photos of your items (or links to your Etsy, Facebook, or Website).
- If your application is not accepted, your payment will be returned in full. By submitting your application, you agree to abide by all 2026 IRC Pumpkin Patch rules and regulations.

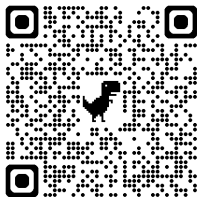
